#### **Board Members:**

As you know, tomorrow evening at 8:00PM we will be having a board meeting to discuss revisions to the Covid-19 procedures and practices in relation to District Convention. The Zoom information is at the bottom of this message.

Attached is you will find the current policy and two possible options with strike-through and red showing proposed changes.

We could opt to do nothing and stay with the current policy. We could opt to go with one of the two option shown here. Or we could opt to pursue another possible option not shown here.

In mid-July, the Covid case numbers in Pennsylvania were down to as few as 100 a day. Today's number was 1,277. The Covid deaths remain in the low double digits and have not seen a significant increase.

We have 158 Kiwanians registered to attend in person, 13 guests and one SLP member.

Presently, the Hilton has not revised their masking requirements of guests. It is my understanding that the Hilton will be sold out on Friday and Saturday night. So there will be lots of folks from lots of places walking around unmasked and while they won't be in our meetings, they will be near and through our meeting areas.

I would, also, remind the board that we have no liability insurance coverage in the event we are hit with a Covid-19 claim. And while we are having folks sign waivers and while it is very unlikely that such a claim could move forward, the best way to insure that is to be proactive if the situation warrants that.

Right now, this will be the only item on our agenda.

Fully vaccinated is defined as having had the second Pfizer, the second Moderna or the Johnson & Johnson shot 14 days prior to attending the convention.

- 2. The District will work with the Hilton Harrisburg hotel to ensure that hand sanitizer stations are available throughout all events and frequent reminders shall be made to utilize those stations.
- 3. No one will be permitted to attend an event without signing and submitting a Covid-19 Liability Waiver and agreeing to the procedures approved by the District board.
